You may only use the title "Test expert for technical installations" in a specific specialist field if you are recognized in this specialist area and this specialist field.  Inspection experts for technical installations can be recognized in various disciplines:  In the field of supply engineering, these are the sub-specializations that include the following systems:  • Ventilation systems including pressurized ventilation systems,  • CO warning systems,  • natural and mechanical smoke extraction systems

and in the field of electrical engineering, the sub-specializations that include the following systems:

- Fire detection and alarm systems,
- safety lighting and safety power supply systems and
- electrical systems.

The recognition procedure will check whether you meet the recognition requirements, in particular whether you have the specialist knowledge required for the job. To determine whether you have the required expertise, you will take an examination at a body appointed by the district government. In addition to completing written and practical tasks, you must also demonstrate your knowledge in an expert discussion. Following state recognition, inspection experts (Section 3 of the Ordinance on the Inspection of Technical Installations and Periodic Inspections of Special Buildings - Inspection Ordinance - PrüfVO NRW) are authorized to inspect technical installations and the fire protection measures required by building regulations for their effectiveness and operational safety.

- Curriculum vitae with complete details of professional career and professional practice up to the date of application,
- a certified copy or photocopy of the final certificate from the training institution and all certificates of previous employment,
- Proof of the application for a certificate of good conduct for submission to an authority (document type O or P) or an equivalent document from a member state of the European Union, which should not be older than three months,
- Declaration by the applicant that he or she will only carry out tests to the best of his or her knowledge and

NRW. p. 272), and that you have at least five years of professional experience in the field in which you wish to carry out the testing activity,</li> <li>have the specialist knowledge required to carry out the activity as an expert in the specialist field to which your expert activity relates and have the necessary testing equipment and aids,</li> <li>your personality is such that you can guarantee that you are up to the tasks of an expert and that you will perform them impartially and conscientiously,</li> <li>prove that you are not already an officially recognized expert in the field in other countries, and</li> <li>prove that you have not yet reached the age of 70</li> </ul>
