Teaser	<p>You have a foreign professional qualification as a tax clerk or assistant tax clerk. Would you like to work permanently in this profession in Germany? Then you can have your foreign professional qualification officially recognized.</p>
Volltext	<p>You can have a training qualification as a tax assistant from abroad officially recognized in Germany. The procedure for recognition is called: equivalence assessment.</p> <p>Please note: Your qualification must be recognized by the state in the country in which you trained. Informal or non-formal qualifications cannot be officially recognized in Germany.</p> <p>You apply for recognition from the competent authority in the federal state in which you wish to work. The chambers of tax consultants are normally responsible for training professions in the field of auditing and tax consultancy.</p> <p>To apply for an equivalence assessment, you must identify a German training qualification or further training qualification. This is the so-called reference profession. It must match your foreign professional qualification. You should therefore seek advice before submitting your application.</p> <p>When assessing equivalence, the competent authority will compare your qualification with a specific German</p>

qualification. Important criteria for the comparison are the content and duration of the training.

You will receive a decision on the outcome of the procedure. The decision will state any existing and any missing professional qualifications. The decision enables employers to better assess your professional qualifications.

You can also apply for equivalence assessment from abroad.

Erforderliche Unterlagen

The responsible office will tell you which documents you need to submit. Important documents are generally

- Proof of identity (identity card or passport)
- Marriage certificate (if your name has changed due to marriage)
- Curriculum vitae
- Proof of your professional qualifications (e.g. certificates, professional certificate)
- Proof of training
- Proof of your relevant professional experience
- Proof of other relevant knowledge for the job
- Have you already submitted an application for equivalence assessment? If so, please state the body to which you submitted the application.
- Perhaps: You come from a third country and do not yet live or work in the EU, the EEA or Switzerland? Then you must provide proof: You want to work in the profession in Germany. Proof can be, for example, applications for a job, invitations to job interviews or a location note from the Central Service Center for Professional Recognition (ZSBA).

The responsible office will tell you which documents you need to submit as a simple copy, a certified copy or the original.

If your documents are not in German, you must submit German translations of your documents. The translations must be made by translators who are

	<p>publicly appointed or authorized.</p> <p>You may have to submit further documents during the recognition procedure. The responsible office will inform you.</p>
Voraussetzungen	<ul style="list-style-type: none"> • You have a state-recognized professional qualification from abroad. • Your professional qualification from abroad is equivalent to a German training qualification as a tax clerk. • You want to work in Germany.
Kosten	<p>Cost framework: Fee: € 100.00 - € 600.00</p> <p>A fee of between €100 and €600 is charged for the procedure in accordance with the current scale of fees of the Lower Saxony Chamber of Tax Consultants. If another procedure according to § 14 BQFG is necessary for the determination of professional qualifications, additional costs will be incurred which would have to be borne by you. A procedure in accordance with § 14 BQFG would only be initiated after consultation and with your consent.</p>
Verfahrensablauf	<p>**Application**</p> <p>You submit an application for equivalence assessment to the competent body. You can submit the application with the documents to the relevant office, send it by post or upload it electronically. Do not send any originals.</p> <p>**Examination of equivalence**</p> <p>The competent body will then check: Is your professional qualification equivalent to the German professional qualification? The competent authority compares the qualifications using certain criteria. Important criteria are the content and duration of the training. The competent body also takes your professional experience, your other certificates of competence and qualifications into account when assessing equivalence.</p>

****Possible results of the examination****

You will receive a notification with the result of the procedure. You will receive recognition if your professional qualification and the German professional qualification are equivalent.

Sometimes there are significant differences between the professional qualifications. The differences are listed in your notification. You can use this decision to gain further qualifications and later submit a new application for equivalence assessment.

If your professional qualification is not equivalent at all, you will not receive recognition.

There is no deadline. Sometimes documents are still missing from the procedure. The responsible office will then inform you by when you must submit the documents.

****Procedure for ethnic German repatriates****

As a late repatriate, you can go through the recognition procedure either in accordance with the laws mentioned here or in accordance with the Federal Expellees Act. You can decide for yourself. The responsible office will advise you on which procedure is right for you.

****Qualification analysis****

You no longer have all the documents required for the application? Then recognition is still possible. You can prove your professional qualification with a

However, you have the right to a recognition procedure. • The procedure is called "equivalence assessment". • The application for recognition can also be submitted from abroad. • The chambers of tax consultants are often responsible for determining equivalence.
