Teaser	Would you like to operate a teleradiology X-ray facility or make significant changes to it? Then you must first apply for a permit from the competent authority.
Volltext	<ul> <li>With the permit, you may put a teleradiology X-ray system into operation or make significant changes to it.</li> <li>Significant changes to a teleradiology X-ray system can be, for example</li> <li>Change of room</li> <li>Structural changes to the room</li> <li>Change of the image receiver</li> <li>The authority will first check whether you have submitted all the necessary documents and meet the legal requirements. Changes in the personnel of the radiation protection officer must also be reported again. If there are no objections to the commissioning or modification, you will receive the permit.</li> <li>If it is a construction procedure, it may make sense to involve the responsible radiation protection authority at an early stage.</li> <li>The application can be submitted online or in paper form.</li> </ul>

Voraussetzungen	<ul> <li>There are no concerns about the reliability of the applicant or the radiation protection officer.</li> <li>The radiation protection officer must have the necessary expertise in radiation protection.</li> <li>You need a sufficient number of radiation protection officers and they must have the necessary authorizations for their tasks.</li> <li>You need sufficient personnel to carry out the work safely.</li> <li>They must have sufficient equipment and appropriate measures to comply with state-of-the-art protection regulations.</li> <li>This is a justified type of activity and does not conflict with any other public law regulations.</li> <li>Authorisation shall only be granted if, in addition to the above-mentioned conditions:</li> <li>I. the availability of the teleradiologist is guaranteed during the examination,</li> <li>it is ensured that the technical performance is carried out by a person who has the necessary specialist knowledge in radiation protection and who is authorised to carry out the technical examination in teleradiology in accordance with the statutory ordinance,</li> <li>it is ensured that a doctor with the necessary knowledge of radiation protection is present at the place of technical implementation,</li> </ul>
	4. there is an overall concept for teleradiological operation that
	(a) ensure the necessary availability of the teleradiology system;
	(b) allows the teleradiologist to be present in person at the site of the technical performance within a period of time necessary for emergency care, as required in individual cases; in justified cases, another doctor who has the necessary expertise in radiation protection

	(c)ensure regular and close involvement of the teleradiologist in the clinical operations of the radiation protection officer
Kosten	The fee is calculated according to the time spent, but is at least 1500 to 2000 euros.
Verfahrensablauf	<ul> <li>You send the application for authorisation to operate or substantially change the operation of an X-ray facility for teleradiology to the competent authority.</li> <li>Upon receipt of the application and the complete dossier, the competent authority will check whether the conditions for authorisation are met.</li> <li>After the application has been reviewed by the competent authority, you will receive the decision in the form of a decision.</li> <li>Finally, you will be sent a notice of costs from the competent authority.</li> </ul>
