Volltext	If you operate a medium-sized combustion plant, gas turbine or combustion engine plant, you will need to determine pollutant emissions by continuous measurements under certain conditions.
	You must prepare a measurement report on the results of the measurements for each calendar year and send it to the immission control authority responsible for you in due time.

Verfahrensablauf	• They evaluate the continuous measurements of each calendar year. • You create a measurement report on the results. • You send the measurement report to the immission control authority responsible for you in due time.
Bearbeitungsdauer	
Frist	• You must submit the measurement report for each calendar year to the responsible immission control authority by 31 March of the following year at the latest. • You must keep the measurement report and the records of the measuring instruments for at least 6 years after the end of the respective reporting period.
