Volltext	<p>Do you want to erect, operate or modify an installation that does not require a permit and is part of the operating area or is part of an operating area? If so, you will require a permit if the distance falls below the appropriate safety distance or a significant increase in risk is triggered.</p> <p>Does the competent authority determine during the review of your previous notification of an accident-relevant construction or modification that your project will trigger the requirements under immission law or a significant increase in risk? Then you also need a permit.</p>

Voraussetzungen	<ul style="list-style-type: none"> The installation must not have any harmful effects on the environment that are technically avoidable. Unavoidable harmful environmental impacts of the installation must be kept to a minimum in accordance with the state of the art. The waste generated during operation of the plant must be disposed of properly. Other regulations under public law and occupational health and safety concerns must not conflict with the project.
