It includes a written and an oral part.</p> <p>The specialization examination counts for 30% of the overall grade. It also includes a written and an oral part.</p> <p>You can decide on the order of the two examinations.</p> <p>The first state law examination is the basis for the preparatory service and therefore also for the second state law examination.</p>
