Teaser	If you, as a recognized breeding association or recognized breeding company, wish to make changes to an existing breeding program, you must notify the competent authority.
Volltext	<p>You must notify the competent authority of any planned changes to your approved breeding program. In doing so, refer to the approval granted to you for the previous breeding program.</p> <p>Make it clear at which points of the breeding program you wish to make changes.</p> <p>You can submit your changes in writing or - if possible - online to the competent authority, which will then review them. If the authority raises no objections within 90 days of your submission, your changes are deemed to have been accepted.</p> <p>As a breeding association or company, when making changes to breeding programs, you must also ensure that the farms participating in your programs are informed of the changes in a timely and transparent manner as soon as they are approved.</p>
Erforderliche Unterlagen	<p>Approval of the existing breeding program to which changes are to be made.</p> <p>The documents must be submitted in writing, either on paper or in electronic form. Required documents:</p>

	<p>\- Breeding program in written format (preferably as a Word file) with color-coded changes</p> <p>\- Written application for changes to the breeding program</p> <p>\- Extract from the minutes of the decision-making body responsible according to the statutes</p>
Voraussetzungen	<p>You carry out an approved breeding program as a breeding association or breeding company.</p> <p>\- Regulation (EU) 2016/1012, Article 9</p> <p>Full text:</p> <p>Regulation (EU) 2016/1012 of the European Parliament and of the Council of June 8, 2016 on animal breeding and parentage rules for the breeding, trade and movement within the Union of purebred breeding animals and hybrid breeding pigs and germinal products thereof and amending Regulation (EU) No 652/2014, Council Directives 89/608/EEC and 90/425/EEC and repealing certain acts in the field of zootechnics ("Animal Breeding Regulation") (Text with EEA relevance)</p> <p>\- TierZG, Section 2, §5</p> <p>Full text:</p> <p>Animal Breeding Act of January 18, 2019 (BGBl. Kosten	<p>The fees are charged in accordance with state law and are calculated on a time and material basis.</p>
Verfahrensablauf	<p>Once the application has been received, the authority will check your documents to ensure that all requirements have been met. If necessary, the authority will request additional information or corrections.</p>

	<p>If all requirements are met and there are no objections, the authority will grant you approval for the breeding program.</p> <p>You will be informed of the decision and can then start implementing the amended breeding program.</p>
Bearbeitungsdauer	Variable depending on effort.
Frist	If the authority raises no objections within 90 days of your submission, your changes are deemed to have been accepted.
