Teaser	Ecclesiastical providers of alternative schools that have emerged from public schools can apply for advance payments for participation in ongoing personnel costs.
Volltext	As a church sponsor of an alternative school that has emerged from a public school, you can apply for a contribution from the state of Lower Saxony towards ongoing staff costs. However, as this application can only be submitted after the end of the school year in question, you have the option of applying for payments on account.

Voraussetzungen	- You are the responsible body for a church-run alternative school that has emerged from a public school. - The school has been in operation for at least three years
