They are subject to the technical supervision of the highest building supervisory authority.</p> <p>Inspection experts for the inspection of technical systems and for earthworks and foundation engineering are commissioned by the client or by third parties on their behalf to carry out inspections/certifications in their specialist area under private law. Within the scope of their duties, they are independent and not bound by instructions.</p>
