Volltext	The trade register is a list kept by the municipal administrations of the tradespeople registered in the municipality who have their registered office in the respective municipality. Public bodies, companies and private individuals can obtain information about the business registration data collected on request. The consent of the person concerned is not required for their data to be passed on.
Erforderliche Unterlagen	- For simple information: no requirements - For extended information: legal interest for example debt instruments, copies of contracts, invoices or similar
Voraussetzungen	- For simple information: no requirements - For extended information: legal interest for example debt instruments, copies of contracts, invoices or similar
Kosten	The trade authorities in Lower Saxony charge corresponding fees in accordance with the Ordinance on Fees and Expenses for Official Acts and Services (General Fee Regulations - AllGO). The amount of the fee for information from the trade notification is based on the time spent in accordance with tariff number 40.1.4 of the Annex to Section 1 (1) AllGO
Verfahrensablauf	- Submit the application for information on business registration data to the responsible office.
