Volltext	If a vehicle that has not yet been registered or a vehicle that has not yet been registered in the Federal Republic of Germany and may have been taken out of service is to be exported abroad under its own power, an export license plate is required.
Erforderliche Unterlagen	 Valid identity card or passport with current confirmation of registration – not older than 3 months or foreign passport

	 SEPA Direct Debit Mandate for the Collection of Motor Vehicle Tax This must be presented in writing in the original, signed by the holder, at the time of approval, also by third parties. In the event of a different account holder, the original of this mandate must be signed by the holder and the account holder. Proof of the bank details provided must be provided. Alternative: a certificate stating that the main customs office waives the collection of motor vehicle tax, or Proof of tax exemption the road tax has already been paid. Proof of payment of motor vehicle tax by means of a tax assessment notice issued by the competent main customs office

- **in the case of third-party processing, additionally:**
- informal, written power of attorney of the applicant and identity card of the person for whom the vehicle is to be registered
- **In the case of companies, additionally:**
- Excerpt from the trade register or commercial register
- the identity documents of the responsible person authorised to sign (managing director, authorised signatory) as well as their power of attorney
- **in the case of registered vehicles, additionally:**
- License plates
- Registration Certificate Part I
- **in the case of decommissioned vehicles, additionally:**
- Confirmation of deregistration (if closed by 30 September 2005)
- Vehicle registration document or the registration certificate Part I with the note of decommissioning

Hinweise	The required license plates can be produced after the application has been submitted. This can be done by contracting a private provider who is located close to the competent authority. The cost of the signs is not included in the fees.
	Due to an amendment to the Motor Vehicle Tax Act, there has been a tax obligation on export license plates since July 1, 2010.

Kurztext	The export license plate entitles the holder to export a vehicle abroad.
Ansprechpunkt	The responsibility lies with the district and the district-free city in which you reside.
