Kosten	The fees are set by the respective authority according to its fee schedule.
Verfahrensablauf	<ul> <li>You must apply for a driver's license for the first time. The driving license authority will determine whether there are any concerns about your suitability. This takes a certain amount of time, which is why the application should be submitted at the latest at the start of driving school training.</li> <li>A driving license can only be issued once the applicant has been checked. The application expires if the theory test has not been passed within twelve months of receipt of the test application or the practical test has not been passed within twelve months of passing the theory test.</li> <li>As a rule, the driver's license is issued upon passing the driving test.</li> <li>The driving license application is generally valid for two years. It expires if the theory test is not passed within twelve months of receipt of the test application or the practical test is not passed within twelve months of</li> </ul>
