Teaser	If you transport goods commercially with motor vehicles whose permissible total weight (including trailer) is more than 3.5 tons, you must apply for a permit from the local traffic authority.
Volltext	Road haulage is the commercial or paid transport of goods with motor vehicles that have a gross vehicle weight of more than 3.5 tons, including trailers.  On May 21, 2022, new regulations on the market and professional access regulations for vehicles over 2.5 tons gross vehicle weight in cross-border traffic will come into force. Accordingly, companies require a Community license for international commercial road haulage with vehicles of more than 2.5 tons and no more than 3.5 tons gross vehicle weight.  This means that in future the conditions for access to the profession, i.e. requirements for an establishment, proof of professional suitability, financial capacity and personal reliability for the aforementioned transports,

must also be met.

Commercial road haulage is generally subject to licensing, whereas so-called own-account haulage, i.e. road haulage for a company's own purposes, is not subject to licensing under certain conditions.

If the vehicles are only used throughout Germany, you require a permit for commercial road haulage (in accordance with Section 3 of the Road Haulage Act). For cross-border journeys within the European Union, the European Economic Area (EEA)\* and Switzerland, you need a Community license (EU license) and, if applicable, a driver's certificate for nationals of a third country.

You can also use the Community license for transports within Germany and the EEA states ("cabotage transports").

For commercial road haulage with countries outside the European Economic Area, you require bilateral permits or so-called CEMT permits in addition to the national permit for the German part of the route (permit for commercial road haulage or Community license) for parts of the route in third countries.

If you are driving in or through Switzerland as part of commercial road haulage, you need a valid Community license.

The permit for commercial road haulage and the Community license can be issued for a limited period, subject to conditions or with conditions. The national permit can be issued for a period of validity of up to 10 years. The Community license is issued for 5 years.

	<ul> <li>the entrepreneur and the person appointed to manage the road haulage business (transport manager) are reliable,</li> <li>the financial capacity of the company is guaranteed and</li> <li>the entrepreneur or the person appointed to manage the road haulage business is professionally qualified.</li> </ul>
	The company requires equity capital plus reserves. The amount of capital is determined by the number of vehicles intended for use. For the first vehicle, the entrepreneur requires equity capital of EUR 9,000, for each additional vehicle EUR 5,000. This also applies to the use of rental vehicles.
	A person is professionally qualified if he or she has passed a professional qualification test. All final examinations previously recognized as equivalent continue to be considered equivalent if they were started or completed before 4 December 2011.
	Persons who have worked continuously (at least ten years) in a managerial position in a road haulage company between December 4, 1999 and December 4, 2009 are also deemed to be professionally qualified.

	Community license: EUR 120.00 - 700.00
	Further costs are incurred for information from the registers and for the preparation of other certificates.
Verfahrensablauf	You must apply for the national road haulage permit or the Community license (EU license) from the transport authority responsible for your place of business.
	You can obtain the application form from the competent transport authority. Online forms are also available, depending on what the authority offers.

	Complete the application in full and submit it with the required documents.
	The competent transport authority will give the following institutions the opportunity to comment:
	<ul> <li>the Federal Office for Goods Transport,</li> <li>the Chamber of Industry and Commerce</li> <li>the relevant trade union and</li> <li>the transport industry association.</li> </ul>
	After the deadline for comments has expired, the competent transport authority will decide on your application. You will receive a decision.
Bearbeitungsdauer	Processing can take up to 3 months from the time at which the responsible office receives all the necessary documents.

Hinweise	Road haulage for the company's own purposes does not require a permit if the following conditions are met:
	<ul> <li>the transported goods must be owned by the company or sold, purchased, leased, rented, manufactured, produced, extracted, processed or repaired by the company.</li> <li>the purpose of the transportation must be to deliver the goods to the company, to dispatch them from the company, to transport them within the company or for the company's own use outside the company.</li> <li>the motor vehicles used for the transportation must always be driven by the company's own staff.</li> <li>The transportation may only be an ancillary activity within the scope of the company's overall activity.</li> <li>If road haulage for the company operating road haulage is obliged to register its business with the Federal Office for Goods Transport before the first transport operation begins.</li> </ul>

	The Federal Office for Goods Transport is responsible for issuing the bilateral permit or a so-called CEMT permit for cross-border commercial road haulage and removal traffic in the community of CEMT member states (over 30 states in Europe).
