If you buy a used vehicle abroad or move to Germany with a vehicle registered to you abroad, you must apply for registration for this vehicle.</p> <p>The registration of a vehicle that was previously registered abroad is more complex compared to a new registration or transfer, as more documents are required.</p>

manufacturer is only sufficient if the vehicle documents of the third country show that the EC type approval number has been recognized for the registration there)

- Electronic insurance confirmation (eVB)
- Bank details for vehicle tax (SEPA direct debit mandate)
- Proof of inspection according to § 29 of the Road Traffic Licensing Regulations (usually main and exhaust gas inspection)
- Customs clearance certificate/proof of customs clearance

Further information can be obtained from your local licensing authority.

If necessary, further documents, e.g.:

- if represented by a third party: your written power of attorney and your identity document (original); the authorised representative must be able to identify himself with his valid identity card/passport.
- in the case of admission to minors: the written declaration of consent of the legal guardians and their identity cards (in the original); If applicable, a certificate of sole custody (so-called "negative certificate") for single parents

### Kosten

The fee is levied in accordance with the Schedule of Fees for Road Traffic Measures (GebOSt). Their amount depends on various factors. In individual cases, information can be obtained from the locally competent licensing authority.

Hinweise	<p>If there are vehicle tax arrears or if you have arrears of fees and expenses from previous registration procedures, the registration authority will refuse registration until you have paid them.</p> <p>If someone registers your vehicle on your behalf, the authorised representative must provide a written power of attorney from you. This must also include a declaration of consent for the licensing authority to inform the authorised representative of any arrears of fees and expenses.</p>
