The application for a green number plate must be submitted to the competent authority when the vehicle is registered. The green license plate remains on the vehicle until it is taken out of service (deregistration) or re-registered to another registration district.

If the conditions for a green number plate are no longer met, a motor vehicle tax can be assessed by the main customs office. From this point on, the green license plate is invalid and must be changed to black.

If you would like to reserve a license plate of your choice, this can be done in person, in writing or by telephone as well as as an online service via the Internet, depending on the offer of the responsible
