| Volltext                         | <ul> <li>Special social difficulties arise from the combination of special living conditions with social difficulties that cannot be overcome independently by those affected.</li> <li>Special living conditions may be (according to § 1 Abs. 2 of the regulation according to § 69 SGB XII): <ul> <li>an insecure economic livelihood,</li> <li>non-existent housing or inadequate housing conditions,</li> <li>violent living conditions,</li> <li>discharge from a closed facility,</li> <li>comparable adverse circumstances.</li> </ul> </li> <li>The aim of the aid is to enable affected persons to cope independently in everyday life according to their possibilities and to enable integration into society.</li> <li>Persons who have found themselves in such difficult living conditions involving particular social difficulties that they are unable to overcome them on their own are entitled to this assistance. The particularly difficult living conditions or social difficulties must be clearly distinguished by a particular degree of severity from the general life crises such as unemployment, illness,</li> </ul> |
