Volltext	For the construction and operation of a petrol station, you need a permit from the competent authority (if necessary in addition to the building permit). Permission can be granted subject to conditions and can be restricted, limited in time and subject to conditions at any time.

Kosten	Acknowledgment of receipt of a notification and the attached documents: The amount of the fees is determined – according to Annex 1 to § 1 paragraph 1 of the General Fee Schedule of the State of Lower Saxony No. 44.1.15.1 – depending on the time spent. However, a minimum of EUR 35.00 will be charged. Checking an ad: The amount of the fees is determined – in accordance with Annex 1 to § 1 paragraph 1 of the General Fee Schedule of the State of Lower Saxony No. 44.1.15.2 – depending on the time required. However, at least EUR 900.00 will be charged.
