Volltext	Anyone who, as a European lawyer, has been admitted to the branch responsible for the place of residence upon application is entitled to practise as a lawyer in Germany under the professional title of their country of origin. The decision on admission shall be taken by the competent authority.

Hinweise	The established European lawyer shall use the professional title which he/she is entitled to use in the country of origin in accordance with the law applicable there. Anyone who is entitled to use the professional title "Rechtsanwältin" or "Rechtsanwalt" must also indicate the professional organisation to which he belongs in the country of origin. The established European lawyer is entitled to use the designation "member of the Bar Association" in professional dealings. The designation "European lawyer" may not be used as a professional title or in advertising.
Rechtsbehelf	
Kurztext	Anyone who has been admitted on application is entitled to practise as a lawyer in Germany under the professional title of their country of origin.
Ansprechpunkt	The jurisdiction lies with the Bar Association. This procedure can also be carried out through a "Point of Single Contact". The "Point of Single Contact" is a special service offered by municipalities and the state for service providers.
