Erforderliche Unterlagen	<ul style="list-style-type: none"> • Curriculum vitae with detailed personal and professional details • Passport photo (not older than one year) • Certified copy of the examination certificates • Diplomas and certificates of qualification relating to the statutory pre-qualification requirements for the examination as a tax consultant • certified copies of certificates and activity certificates relating to previous professional activity, in particular with details of the type and scope of activity in the field of taxes administered by the federal or state tax authorities • Proof of working hours • In addition, a certificate from the Chamber of Public Accountants is required confirming that the applicant is a certified public accountant or a sworn auditor or has passed the examination as a certified public accountant or sworn auditor.
