| Volltext | <p>According to the Vocational Training Act (BbIG), parts of vocational training can be carried out abroad if this serves the training objective (extra-company vocational training). The total duration of the stay abroad should not exceed one quarter of the training period specified in the training regulations.</p> <p>The competent authority (e.g. the respective chamber) monitors and promotes the implementation of stays abroad in an appropriate manner. If the duration of a training period abroad is more than four weeks, a plan agreed with the competent authority is required. Therefore, the competent authority should be informed about the stay abroad.</p> <p>Foreign educational qualifications and periods of professional activity abroad are also taken into account when admitting to the examination.</p> |

| | <p>abroad.</p> <p>For the duration of their stay abroad, trainees must apply for a leave of absence from compulsory vocational school at their respective vocational school in Germany. There are different regulations in the federal states. A leave of absence is usually possible for a period of up to nine months. However, the missed vocational school material must be made up by the trainees themselves.</p> <p>All participants in a mobility project must have health, accident and liability insurance.</p> |

This can be, for example:</p> <ul style="list-style-type: none"> • the Chamber of Crafts for vocational training in occupations covered by the Crafts Code, • the Chamber of Commerce and Industry for vocational training in non-craft trades, • the Chamber of Agriculture for vocational training in agricultural and rural home economics occupations, • the Chamber of Lawyers, Patent Attorneys and Notaries as well as the Notarial Fund for the vocational training of specialists in the field of administration of justice, • the Chamber of Auditors and the Chamber of Tax Consultants for the vocational training of specialists in the field of auditing and tax consulting, • the Chamber of Doctors, Dentists, Veterinarians and Pharmacists for the vocational training of specialists in the health professions. <p>Further responsibilities, e.g. for bodies under public law as well as for churches and other religious communities, are regulated in the Vocational Training Act (BBiG).</p> |
