| Volltext                   | <p>The municipal electoral authority keeps an official voters' register for each electoral district. Only those who are entered in the electoral roll can exercise their right to vote in state parliament elections.</p> <p>The basis for entry in the voters' register is the municipality's population register. In principle, citizens entitled to vote who are registered as having their main place of residence in the municipality on the 35th day (cut-off date) before the state parliamentary election are entered ex officio. The municipality will notify you in writing by the 28th day before the election at the latest.</p> <p>If you have not received a polling card by the 28th day before the election, you should immediately check with your municipality whether you are on the electoral roll. If this is not the case, you can apply to be entered.</p> <p>If your circumstances are different, e.g. you moved to the municipality after the 35th day before the election or your permanent residence is a secondary residence, please contact the municipal electoral authority immediately.</p> |
