Volltext	<p>Displays of persons are events at which the physical appearance of the persons on show is the main focus. The performances offered by them (e.g. singing or theater performances) are in the background. This term mainly covers events that</p> <ul style="list-style-type: none"> • display the sexual charms of the persons concerned or • are intended to satisfy the sensationalism of the audience. <p>Examples: Striptease or table dance</p> <p>A permit is required for the commercial exhibition of persons. This can be obtained by natural and legal persons. The permit is required by</p> <ul style="list-style-type: none"> • the organizer of the performance and • persons who make their business premises available for the performance. <p>The permit for the exhibition does not replace any other permits.</p> <p>Note: Performances of a predominantly artistic, acrobatic, sporting or similar nature are exempt from the permit requirement.</p>
