Teaser	If you wish to erect or alter a gravestone or other structure in a cemetery, you must obtain the consent of the respective cemetery administration.
Volltext	If you wish to erect or alter a gravestone or other structural installation in a cemetery, you must obtain the consent of the respective cemetery administration. In the case of municipal cemeteries, this is the local cemetery office. The cemetery authorities have drawn up statutes that contain guidelines with more or less detailed information on the design and nature of graves, including the planting of graves. Stonemasons who offer gravestones must inform themselves about the existing guidelines. They are obliged to only offer their clients gravesites that comply with the cemetery statutes.
Erforderliche Unterlagen	Proof of the right of use of the gravesite; written power of attorney, if authorized representative; Please contact the relevant office to find out which documents and proof are required in your specific case.
Voraussetzungen	The procedure is not uniformly regulated, please enquire with the responsible responsible office about the requirements.
