Teaser	Were you, your child or another close family member in the ascending or descending line of descent born abroad? Then you can have the birth subsequently certified in the birth register at the registry office responsible for you.
Volltext	If you or a close family member in an ascending or descending line of descent was born abroad, you can apply for subsequent certification of the birth in the register of births (formerly the register of births) at the registry office in Germany.
	You apply for the certification at the registry office that is responsible for your German place of residence or the German place of residence of the person entitled to apply. If neither a current nor a former German place of residence can be determined, you can apply for the certification at your competent German mission abroad or at the registry office Berlin I.
	You are not obliged to have the birth subsequently certified. Birth certificates from abroad are often recognized in Germany as long as their authenticity is beyond question.
	However, the subsequent entry in the birth register can be advantageous because the local registry office can then issue you a German birth certificate. This means that you no longer have to have the foreign certificate translated and certified for future requests.

	<ul> <li>foreign birth certificate with translation; legalization or apostille if necessary</li> <li>valid identity card, passport or travel document</li> <li>marriage and birth certificates of the parents of the person to whom the entry refers</li> <li>naturalization certificate or citizenship certificate, if applicable</li> <li>If applicable, other documents with proof of authenticity and, if applicable, translation, depending on the individual case.</li> <li>You must submit all documents in original.</li> </ul>
Voraussetzungen	<ul> <li>You have German citizenship, are stateless or a recognized refugee whose habitual residence is in Germany.</li> <li>You apply for certification for yourself, your child a parent or your spouse or partner.</li> </ul>
Kosten	State of Brandenburg: Costs are charged for certification in accordance with subheadings 12.3.2.4 – 12.3.2.4.4 of the Annex to the Ordinance on Fees for Public Services in the Field of the Ministry of the Interior and for Municipal Affairs (Schedule of Fees of the Ministry of the Interior and for Municipal Affairs - GebOMIK)

	<ul> <li>certificates from abroad are often recognized, especially from EU countries</li> <li>Subsequent certification necessary for issuance of a German birth certificate</li> <li>application possible for person himself or for close family members in ascending or descending line of descent</li> <li>all documents must be original or notarized</li> <li>responsible: Registry office at the German place of residence or abode of the person born abroad or of the person entitled to make the application</li> </ul>
