Teaser	Do you need the current address or certain other information about a person you know? It is possible to submit an application to the registration authority for the provision of a population register information.
Volltext	<p>In order to obtain extended information about specific individuals, you must demonstrate a legitimate interest.</p> <p>You will receive information about the surname, first name, doctor's degree, current addresses and, if the person is deceased, a reference to this.</p> <p>In addition, you will receive information about previous names, date and place of birth and, if the person was born abroad, also the country, marital status, limited to whether or not the person is married or in a civil partnership, current nationalities, previous addresses, date of moving in and moving out, surname and first names and address of the legal representative, surname and first names and address of the spouse or civil partner, date and place of death and, if the person died abroad, also the country.</p> <p>The registration authority will immediately inform the person concerned, stating your name as the person requesting the information, that the extended information has been provided. You can prevent this if you can demonstrate a legal interest to the registration authority that the person concerned does not need to be informed. A special reason is the assertion of legal claims</p>

Voraussetzungen	<p>You must be able to credibly demonstrate a legitimate interest in the provision of information.</p> <ul style="list-style-type: none"> • The term "legitimate interest" includes any legal, economic or non-material interest that is deemed worthy of protection. • The person you are looking for is clearly identified by the information you provide. • No information block has been entered in the civil register and there are no indications that the person(s) sought or another person could be endangered by the provision of information for interests worthy of protection.

Verfahrensablauf	<p>Written request with the data of the requesting person (surname, first name, address).</p> <p>The provision of extended population register information is only permitted if the identity of the person about whom information is requested can be clearly established on the basis of the information provided in the request about the surname, the previous name, the first names, the date of birth, the gender or an address.</p> <p>The information is provided in writing to the applicant.</p>
