Volltext	Parties, electoral groups and other sponsors of election proposals may obtain the following information on persons entitled to vote from the civil register in the 6 months prior to an election in connection with parliamentary and municipal elections: • First and family names, • degree of doctor, • current address. If the person inquired about is deceased, this will be communicated.

Voraussetzungen	The applicant must be a party, voter group or other sponsor of nominations in connection with elections and votes at the state and local level. Information only admissible in the six of the election

Kosten	Information to parties, voter communities and individual candidates according to time expenditure, but at least € 50.00 and a maximum of € 250.00 plus € 0.20 per selected inhabitant
Verfahrensablauf	You can apply for this information from the population register in person or in writing to the registration authority.
Bearbeitungsdauer	1 to 3 weeks
Frist	The information can only be provided in the 6 months prior to an election. This data may only be used for advertising in an election or vote and must be deleted or destroyed no later than one month after the election or vote.

Hinweise	The registration office cannot provide any information if a block on information exists or a blocking notice is entered in the register of residents. Furthermore, every data subject has the possibility to object to the transmission of his or her data.
