Teaser	Under what conditions do you receive maternity benefit?
Volltext	During the periods of protection before and after childbirth and for the day of childbirth, you can receive maternity allowance. If you are a member of the statutory health insurance scheme, apply for maternity benefit to your health insurance company. If you are privately insured or covered by family insurance and are in an employment relationship at the beginning of the protection period (including a minor employment relationship/mini-job), you apply to the Federal Insurance Office and receive a maximum of EUR 210.00 once. Self-employed women who are not insured with a statutory health insurance fund with entitlement to sickness benefit, but who have private health insurance, do not receive maternity benefit. Self-employed women who are insured with a statutory health insurance fund entitled to daily sickness benefit receive maternity allowance in the amount of the sickness benefit.
