Teaser	<p>Entry in the register of engineers entitled to submit building documents in the State of Brandenburg</p> <p>In order to be commissioned as an author of building templates, an entry in the list for engineers entitled to submit to the building documents at the State Chamber of Engineers is a prerequisite.</p>
Volltext	<p>Engineers entitled to submit building documents are entitled to create building templates for the non-process-free construction and modification of buildings. Anyone wishing to work as an engineer entitled to submit building documents must be a member of the Chamber of Engineers and entered in the list of engineers entitled to submit building documents.</p> <p>Upon request, the list shall include those who meet the requirements prescribed in § 65 of the Brandenburg Building Code. The list of engineers authorized to submit building documents is maintained by the Brandenburg Chamber of Engineers.</p> <p>Note: If you are already registered in such a list of another federal state, this entry is also valid in Brandenburg.</p> <p>Established persons entitled to submit building documents from other EU/EEA countries:</p> <p>If you are established in another member state of the</p>

EU or the EEA as an authorised building submission or authorised building submission, you are entitled to submit building documents without entry in the list of design authors. In this case, you must:

- have a comparable authorization, and
- meet the comparable requirements for inclusion in the list of draftsmen.

You must report your activity to the Brandenburg Chamber of Engineers before you act for the first time as an authorized building submission or building submission authorized. Upon request, the Chamber of Engineers will confirm that the notification has been made.

If the requirements in your country of origin are not comparable with those in Brandenburg, you must obtain certification that you meet the requirements required for entry in the list of draftsmen. You must apply for the certificate from the Brandenburg Chamber of Engineers, which will enter it in its own register after the certificate has been issued.

Note: If you have already displayed your activity in another federal state, an ad in Brandenburg is not necessary. This also applies to the issue of the certificate.

Erforderliche Unterlagen

The following supporting documents must be submitted with the completed application:

- Notarized Copy of the certificate as an engineer or adequate
- (certified) Copy of the certificate of engineering degree or an equivalent degree
- Curriculum vitae / professional career
- Proof of professional liability insurance (maximum 3 months old, minimum coverage according to §10 BrbIngG)
- If applicable, proof of self-employment, e.g. management of a GmbH or similar (see application form)
- If applicable, confirmation of registration with

Voraussetzungen	<p>To be added to the list of draftsmen, you must:</p> <ul style="list-style-type: none"> • provide proof of a university degree qualifying for a profession in the field of building construction or civil engineering, • have worked practically in the field of building design for at least two years after graduation, • have their domicile or professional establishment in the State of Brandenburg and • prove that you have taken out sufficient professional indemnity insurance.

Verfahrensablauf	<p>Registration shall be made upon written request.</p> <ul style="list-style-type: none"> • Download and print the form online. • Fill in the form and attach the necessary supporting documents. • Submit the application to the Brandenburg Chamber of Engineers. • The application is processed by the Registration Committee (which may provide explanations or requests for subsequent submission of documents). • You will then receive a notification from the Registration Committee by post.
