Teaser	Municipalities can notify the Ministry of the Interior responsible for the state of the introduction and/or modification of a municipal coat of arms. Approval is required if no approval has previously been granted by the state archives to be involved.
Volltext	A coat of arms is a symbol in the form of a shield created according to certain rules. Coats of arms represent people, families, certain groups of people or personified objects, organizations and communities. Each federal state has its own coat of arms. In addition, there are the coats of arms of the municipalities. The use of the respective coat of arms of the community requires the approval of the respective municipality.
