Teaser	Have you had to close your business or practice due to an activity ban or quarantine? Here you can find information on how the reimbursement of ongoing non-covered operating costs takes place.
Volltext	In the event of a ban on activities or a quarantine, as a self-employed person or self-employed person, in addition to the claim for compensation for loss of earnings, you also have a claim for reimbursement of continuing non-covered operating expenses, such as rent or loans. This only applies to operating expenses that cannot be avoided. You must also keep operating costs as low as possible. Reimbursement is made to a reasonable extent. This is a so-called "optional benefit". This means that the authority has leeway in assessing whether a claim exists and how high it is.
