Teaser	You can have your residence permit extended for the purpose of carrying out a qualification measure for the recognition of your foreign professional qualification before the expiry of its period of validity if you fulfil certain conditions for this purpose
Volltext	The residence permit to carry out a qualification measure is a temporary residence title. You can apply for an extension of the residence permit if the qualification measure(s) has/have not yet compensated for the identified deficits of foreign qualification, e.g. because you have to repeat an examination or the examinations are preceded by long waiting periods.  The same requirements apply to the extension of the residence permit for the purpose of carrying out a qualification measure as to the granting of the residence permit. In particular, your livelihood should be secured for the entire duration of the qualification measure(s).
	In the case of an extension, your residence permit will be limited again. The residence permit for the purpose

	of carrying out a qualification measure can be extended by six months. However, the total duration of stay for the purpose of carrying out the qualification measures may not exceed two years.
	As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.
Erforderliche Unterlagen	<ul> <li>Passport or passport replacement</li> <li>Current biometric photo</li> <li>Existing residence permit</li> <li>Proof of means of subsistence (e.g. blocked account at a bank)</li> <li>Proof of health insurance</li> <li>Rental contract</li> <li>Proof of qualification measures, if applicable further education plan</li> </ul>
Voraussetzungen	<ul> <li>You have a recognised and valid passport or passport substitute as well as the valid residence permit to carry out a qualification measure for the purpose of recognising your foreign professional qualification in accordance with Section 16d (1) of the Residence Act.</li> <li>The period of validity of your residence permit will expire in the near future.</li> <li>There is no interest in deportation against you.</li> <li>Your stay does not endanger or impair the interests of the Federal Republic of Germany.</li> <li>The qualification measure is still suitable to enable the recognition of the professional qualification or the access to the profession.</li> <li>Your livelihood is secured.</li> </ul>
Kosten	<ul> <li>Extension of the residence permit to carry out a qualification measure for the recognition of foreign professional qualifications:</li> <li>For a further stay of up to three months: EUR 96 for a further stay of more than three months: EUR 93</li> <li>Under certain conditions, a fee reduction or fee exemption may be considered.</li> </ul>
Verfahrensablauf	You must apply for the extension of your residence permit at the aliens' registration office responsible for your place of residence.

	<ul> <li>Depending on the foreigners authority and your concerns, it may be possible to apply via the internet. Find out whether your foreigners authority offers electronic application for the residence permit.</li> <li>If the application can only be submitted in person, arrange an appointment with the Aliens' Registration Office.</li> <li>During the appointment, your application will be received and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuing of the electronic residence permit (eAT).</li> <li>In the case of an electronic application, the Aliens' Registration Office will contact you after receiving your online application to arrange an appointment at the Aliens' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the issuing of the eAT card.</li> <li>If your application is granted, the Aliens' Registration Office will arrange for the eAT card to be produced.</li> <li>After about six to eight weeks, you can collect your eAT card from the Aliens' Registration Office.</li> <li>There are fees for the extension of the residence permit. The time and form of payment vary depending on the authority.</li> </ul>

Frist	<ul> <li>Extension of the residence permit: at the latest eight weeks before the expiry of your still valid residence permit.</li> <li>Objection period: 1 month</li> </ul>

### Kurztext

- Residence permit for the purpose of training Extension to carry out a qualification measure
- Residence permits for the purpose of carrying out a qualification measure for the recognition of foreign professional qualifications can be extended if their period of validity is due to expire in the near future but the qualification measures have not yet compensated for the identified deficits in the foreign qualification.
- The extension must be applied for no later than eight weeks before the expiry of the time limit.
- An extension of the residence permit for the purpose of carrying out a qualification measure is only possible if the prerequisites which existed when the permit was first issued continue to apply.
- In the case of an extension, the residence permit is again limited in time.

	<ul> <li>The extension is excluded if the extension was already excluded by the foreigners authority when the permit was issued or the last extension was issued.</li> <li>Depending on the Foreigners' Registration Office and the request, the application can be made via the Internet or only in person.</li> <li>There are fees for the extension. The time and form of payment vary depending on the authority.</li> <li>Responsible: the foreigners authority responsible for the applicant's place of residence.</li> </ul>
