Teaser	Commercial gaming brokerage requires a permit.
Volltext	Anyone wishing to commercially broker public games of chance in the state of Brandenburg requires a license in accordance with Section 3 of the Brandenburg Gambling Implementation Act, irrespective of other notification obligations. The brokerage shall only be carried out by organizers who have a permit from the competent authority of the State of Brandenburg or the competent authority pursuant to Section 9a of the State Treaty on Gambling. The license application must be submitted in writing to the Ministry of the Interior and Municipal Affairs. The requirements for the granting of a permit can be found in Section 19 of the State Treaty on Gambling. Commercial gaming brokerage is not permitted in local business premises. Kosten	The fees are calculated according to time spent (hourly rates) (Fee Act for the State of Brandenburg and Fee Schedule MIK): • For employees of the higher service or comparable tariff employees: 80 euros • For employees of the higher service or comparable tariff employees: 60 euros • For employees in the intermediate service or comparable tariff employees: 48 euros and • For employees in the elementary service or comparable tariff employees: 38 euros
