Teaser	You can have your residence permit for the subsequent immigration of spouses extended if you meet certain requirements.
Volltext	<p>The residence permit for the reunification of spouses with foreigners is a temporary residence title. You can apply for an extension of the residence permit if you wish to stay in Germany and your spouse or partner is in possession of a valid residence permit in Germany.</p> <p>In principle, the same conditions apply for the extension of the residence permit as for its issue.</p> <p>If your residence permit is extended, it will be limited in time again. The residence permit is extended for the period of validity of the spouse's or partner's residence permit.</p> <p>As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.</p> <p>If you were obliged to take part in an integration course when your residence permit was first issued, this will be taken into account when your residence permit is extended. If you have not yet taken part in an integration course, the immigration authority may</p>

	<p>reject your application to extend your residence permit. If you have not yet completed the integration course, the residence permit will generally only be extended for one year at a time until you successfully complete it or provide proof that you have been integrated into society and social life in another way.</p>

- Depending on the foreigners authority and your request, it may be possible to apply online. Find out whether your foreigners authority offers electronic application for a residence permit.
- If the application can only be made in person, arrange an appointment with the immigration office.
- During the appointment, your application will be accepted and your supporting documents checked (please bring these with you to the appointment). Your fingerprints will be taken to issue the electronic residence permit (eAT).
- In the case of an electronic application, the Foreigners' Registration Office will contact you after receiving your online application to arrange an appointment at the Foreigners' Registration Office. During the appointment, your documents will be checked (please bring them with you to the appointment) and your fingerprints will be taken for the eAT to be issued.
- If your application is approved, the Foreigners' Registration Office will arrange for the eAT to be issued.
- After about six to eight weeks, you can collect the eAT from the Foreigners' Registration Office.

- Extension of the residence permit: no later than eight weeks before your valid residence permit expires

- Residence permit for family reasons Extension for spouses joining foreigners
 - The residence permit for the person joining the family member can be extended if it is due to expire in the near future and the marriage/life partnership continues.
 - The residence permit for the person joining the family will be extended for the duration of the family member's residence permit in Germany.
 - In principle, the same conditions apply for the extension of the residence permit as for its issue.
 - The extension must be applied for at least eight weeks before the expiry date.
 - The extension is excluded if the extension was already excluded by the immigration authority when the residence permit was issued or when it was last extended.
 - If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed, the immigration authority may refuse to extend the residence permit or only extend it for one year until the course has been successfully completed or proof has been provided that integration into social life has taken place in another way.
 - Depending on the foreigners authority and your request, you can apply online or in person.
 - Fees are charged for the extension. The time and form of payment vary depending on the authority
