Teaser	<p>Do you want to handle or transport explosive substances commercially? Then you need a permit from the local explosives authority.</p> <p>If you wish to handle and transport explosive substances commercially, you must first apply for a permit from the State Office for Occupational Safety, Consumer Protection and Health (LAVG)</p>
Volltext	<p>If you want to handle or transport explosive substances in the commercial sector, you need a permit from the local explosives authority.</p> <p>Activities in connection with explosive substances have a high risk potential. The aim of the Explosives Act is to protect people and property from these dangers. In order to prevent accidents and misuse, the Explosives Act places high demands on persons who wish to handle explosive substances.</p> <p>These include the following proofs:</p> <ul style="list-style-type: none"> • Age (at least 21 years old) • Suitability, • reliability and • specialist knowledge. <p>As part of the proof of reliability, information is obtained from other authorities, such as the police, the public prosecutor's office and the constitutional protection authority.</p> <p>As an entrepreneur, you require a permit to handle and trade the following explosive substances, for example:</p> <ul style="list-style-type: none"> • Explosives, for example. Explosives or pyrotechnic sets • NC powder (nitrocellulose powder) or black powder • Stage pyrotechnics/technical pyrotechnics

Sachverhalt

- Category F3 and F4 fireworks,
 - Category F2 fireworks listed as requiring a permit in accordance with the First Ordinance to the Explosives Act, e.g. with flashbangs
- The official permit ensures that only persons who meet the requirements for safe handling have access to explosive substances.
- If necessary, when applying for a commercial permit, the competent authority will ask you for further information on the available storage options for explosive substances.

Erforderliche Unterlagen

- Valid identity card or passport
 - Proof of expertise or proven competent person (certificate of competence holder)
 - Description of the intended storage (e.g. technical documentation, photographic evidence, storage plan)
 - For checking the reliability of persons from abroad:
 - You will need a certificate in the form of a certified translation from the competent judicial or administrative authority in your home country or country of origin regarding certain facts that are relevant to the assessment of your reliability (e.g. criminal record extract).
- Regional explosives authorities may require further documents.

Voraussetzungen

- In order to obtain a permit to handle and transport explosive substances, you must meet the following requirements:
- You must be 21 years of age or older to handle explosive substances.
 - You must have specialist knowledge. Proof of specialist knowledge is provided in the form of a certificate attesting to successful participation in a state or state-recognized training course.
 - They must be reliable. The required reliability is normally given if you have previously behaved in accordance with the law and have no criminal record.
 - You must be personally suitable. You are personally suitable if you have no restrictions, for example in terms of mental or physical health or due to drug or alcohol addiction.
 - You must have suitable rooms or storage facilities for safekeeping.

As a rule, fees are calculated on the basis of expenditure and benefit on the basis of a cost framework.</p> <p>Fees in the state of Brandenburg:</p> <ul style="list-style-type: none"> • Issuing the permit: EUR 150.00 - 300.00 plus the fee for obtaining information as part of the reliability check, depending on the time required • Amendment of the permit: EUR 50.00
