Teaser	For planned measures or changes in the vicinity of monuments, you regularly need a permit from the lower monument protection authority.
Volltext	<p>Various measures that you intend to take in the vicinity of monuments must first be checked and approved by the lower monument protection authority.</p> <p>In this way, possible effects on the substance or appearance of monuments or any changes in the urban context can be estimated at an early stage.</p> <p>Examples:</p> <ul style="list-style-type: none"> • erection, modification or removal of structures, or • garden and landscaping; • excavation and foundation work; • soil replacement; • road construction; • pipe laying; • exchange and planting of trees and shrubs; • Elimination of uncontrolled growth. <p>Interventions in the soil of ground monuments also require permission.</p> <p>Note: You cannot start taking action until you have a permit. Therefore, contact the lower monument protection authority at an early stage.</p>
Erforderliche Unterlagen	Each measure shall be described in detail. You should submit all documents that contribute as fully as possible to the assessment of your project. These can be:

	<ul style="list-style-type: none"> • Plans (e.g. location, floor plans, views, sectional representations) • Documentation • Photographs • Expert opinions or preliminary investigations • Cost and profitability calculations <p>Note: Contact the lower monument protection authority in good time. This will inform you which documents are required for your approval procedure.</p>
Voraussetzungen	<p>You will usually receive approval if:</p> <ul style="list-style-type: none"> • the measures are carried out according to monument conservation principles <p>or</p> <ul style="list-style-type: none"> • overriding private or public reasons must be taken into account.

Verfahrensablauf	<ul style="list-style-type: none"> • Fill out the application either online or print out the PDF form. • Attach all necessary documents. • Submit the application documents to the responsible lower monument protection authority in good time before the start of the planned measures. • You will then receive the approval or, if necessary, information about the rejection of your application by post.
Bearbeitungsdauer	<p>4 weeks after submission of the complete application documents</p>
Frist	<p>Expiry of the authorisation • if construction does not start: 4 years after approval • in the event of a construction interruption of more than 2 years (one-time extension of up to 2 years upon written request)</p>

Hinweise	<p>If you apply for a building permit, the responsible building supervisory authority will obtain the approval of the monument protection authority as part of the approval process.</p> <p>In this case, you do not need to apply for a permit from the monument protection authority.</p>
