Teaser	If you are a company, you can be entered in the Official Register of Prequalified Companies (AVPQ) by providing one-off proof of your reliability and suitability to the relevant Chamber of Industry and Commerce.
Volltext	In order to participate in public contracts, your company must prove that none of the legally defined formal grounds for exclusion exist. grounds for exclusion. The entry in the directory is considered proof of suitability, meaning that you only need to provide an individual access code or enclose a copy of

the certificate each time you submit a tender. As a prequalified company, you have a presumption of suitability. This means that public clients will only request proof of your suitability if there are reasonable doubts.

As a prequalified company or freelancer, you can be found using various search criteria such as name, registered office, CPV code, etc., e.g. when public clients are looking for suitable companies.

As a company from the supply and service sector (including freelancers), you can apply for registration. You are only excluded if you are purely a construction company, as there is a different directory for construction companies.

In order to retain your prequalification, you must submit the proof of suitability to the prequalification body responsible for your (main) place of business once a year after registration for preliminary examination. After a final check by the responsible Chamber of Industry and Commerce, your company will be entered in the official register.

In addition to the mandatory certificates, you can submit further evidence of the company's/freelancer's qualifications. These are also subject to review and can be viewed by the contracting authority as deposited documents.

The documents checked by the CCIs can only be viewed by the contracting authority that has the certificate with its specific access code. However, the official directory is generally accessible.

The directory is updated every day.

The prequalification body in Brandenburg is the Auftragsberatungsstelle Brandenburg e.V.

- Extract from the commercial, association, partnership or cooperative register (depending on legal form and

registration requirement)

- Business license, depending on the need for a business license
- Business registration/deregistration (does not apply to freelancers)
- Membership certificate from the Chamber of Industry and Commerce, Chamber of Crafts or a professional chamber
- Certificate/confirmation of professional/ public liability insurance
- Self-declaration that there is no serious misconduct (If there are more than three persons with sole power of representation, a declaration signed by three persons is sufficient. This must include the person responsible for public procurement).
- Certificate in tax matters from the tax office, in Saxony self-declaration
- When applying for a GmbH & Co. KG: certificate for both the GmbH & Co. KG and the GmbH
- Certificate for statutory social insurance (health insurance certificate)
- Clearance certificate from the employers' liability insurance association
- Central trade register excerpt GZR 3 (for sole proprietorships) or central trade register excerpt GZR 4 (for legal entities, commercial partnerships and associations), when applying for a GmbH & Co. KG: GZR 4 for the KG and GZR 4 for the GmbH
- Note: Some of the certificates must be submitted in the original and must not generally be older than three months. Further information can be found in the additional information.

State of Brandenburg:

As a rule, the self-declaration must be signed by the managing director.

Bearbeitungsdauer	<p>Once the documents are complete, prequalification generally takes no longer than three weeks and subsequent registration by the Chamber of Industry and Commerce takes a maximum of six working days.</p>
Frist	<ul style="list-style-type: none"> • The certificate of entry in the Official Register is valid for one year. This period begins from the date of registration. • If there are any changes to your company's proof of suitability and reliability during the

Rechtsbehelf	<p>The refusal of registration is an administrative act. Depending on state law, an objection or administrative court action may be possible. You can find detailed information on this in the rejection notice.</p>
Kurztext	<ul style="list-style-type: none"> • The prequalification database for the supply and services sector lists companies that have proven their suitability for public contracts <ul style="list-style-type: none"> • Prequalification valid for one year • This saves companies considerable time and money. • Public contracting authorities can be sure that the verification is serious and that bids do not have to be excluded from public tenders due to incorrect proof of suitability • Possible for all tradespeople and freelancers, there is only a separate list for providers of construction services • General contractors can exclude their liability for the social security contributions of their subcontractors in accordance with the Parcel Carrier Protection Act if the subcontractors are entered in the official register.
