Teaser	<p>Accidents involving certain work equipment or systems requiring monitoring in which a person has been killed or seriously injured must be reported immediately.</p> <p>Has a person been seriously injured or even died in your company? Then you must report this.</p>
Volltext	<p>If an accident occurs during the use of work equipment and a person is seriously injured or killed, you as the employer must report this to the occupational health and safety authority.</p> <p>This applies to accidents involving the following work equipment</p> <ul style="list-style-type: none"> <li>• elevator systems</li> <li>• pressurized systems</li> <li>• Installations in potentially explosive atmospheres</li> <li>• cranes</li> <li>• liquid gas systems</li> <li>• mechanical equipment for event technology</li> </ul> <p>The competent authority must be notified immediately of any accident in which a person has been killed or seriously injured.</p>

## Sachverhalt

### Erforderliche Unterlagen

Informal notification with the following details:

- Address of the company
- Address of the business premises or construction/assembly site at the incident location
- Date of the incident
- Type of incident (e.g. explosion, media leak, crash)
- Number of persons injured, number of persons killed
- Work equipment involved
- Approved monitoring body involved (for installations requiring monitoring in accordance with Annex 2 of the Ordinance on Industrial Safety and Health)
- Agency involved in determining the cause (for work equipment in accordance with Annex 3 of the Ordinance on Industrial Safety and Health)
- Brief description of the incident and the damage that occurred (including photos and videos) Measures already initiated by the employer

The occupational health and safety authority may also request the following information from you:

- Risk assessment
- Proof that a competent person has prepared the risk assessment
- Details of the persons responsible
- Details of the protective measures taken
- Proof of regular instruction of employees
- Operating instructions

The notification must contain the following information:

- Details of the person,
- their work area,
- Description of the course of the accident
