Verfahrensablauf	For recognition purposes, the competent body will check on the basis of your certificates whether and to what extent your foreign qualification corresponds to a German qualification for your chosen profession. This check is based on defined formal criteria, such as the content and duration of the training. Your relevant professional experience is also taken into account, as are other relevant qualifications. For academic qualifications, you can apply for an assessment by the Central Office for Foreign Education (ZAB).
	Further information on German professions, recognition procedures and the relevant authorities can also be found on the "Recognition in Germany" portal. This internet portal provides quick and easy answers to questions about recognition, for example
	 Do I have to have my professional qualification recognized? Is recognition worthwhile for me? Can I submit the application? Do I have a formal right to it? Which authority do I have to contact? 	• In professions for which a permit is required, the recognition procedure can also be carried out via the single point of contact (currently within the scope of the EU Services Directive, from 18 January 2016 also within the full scope of the EU Professional Qualifications Directive) NOTE: The deadline for submitting the application begins when the competent authority confirms that the required documents have been submitted in full
