This also means that you cannot contest an examination if you submit the application afterwards.</p> <p>Hint: The assessment of the respective facts and the design of appropriate measures depends crucially on the individual case.</p> |

- Application required

- Proof of eligibility required (e.g. medical certificate, severely disabled person's ID, care level notice, maternity passport, birth certificate of the child)
- individual agreement with the university or decision by the university (examination board)
- responsible: the respective university
