<b>Teaser</b>	If you have completed a journeyman's or final examination in a recognized skilled trade and have qualified professional experience, you can become self-employed or take on a managerial role in most skilled trades requiring a license.
<b>Volltext</b>	<p>Anyone who has passed a journeyman's examination or a final examination in a recognized training occupation and has gained relevant professional experience can become self-employed or take on a managerial role in many trades requiring a license. The professional qualification must have been acquired in the trade that is to be practiced. For certain trades, it is sufficient if the professional qualification was acquired in a related trade, which can be found in the ordinance on related trades.</p> <p>In addition to a journeyman's or final examination, proof of relevant professional experience is also required, which must have been acquired after the training. At least six years of professional experience is required, of which at least four years must have been in a managerial position. A managerial position can be assumed if the person concerned has been given independent decision-making powers in a company or a significant part of a company, which must be</p>

The granting of a license to practice for journeymen or journeywomen with qualified professional experience is not possible for chimney sweeps and health trades (opticians, audiologists, orthopaedic technicians, orthopaedic shoemakers, dental technicians).</p>

Proof of a managerial position in a company or a significant part of a company can be provided, for example, in the form of job references and job descriptions.</li> </ul>

- Go to the website of your local Chamber of Skilled Crafts or to the service portal of your federal state and select the correct online service.
- The online service will guide you through the application step by step.
- You can submit the required documents digitally.

Written application:

- Go to the website of your local Chamber of Skilled Crafts.
- Download the application forms for a license to practice.
- Complete the forms in full and send them to your local Chamber of Skilled Crafts together with the required proof of your knowledge.
- Your application and the evidence will be checked by the Chamber of Skilled Crafts. If the evidence is not sufficient, you may have to take an examination of expertise.

After your documents have been checked, you will receive a license to practice and a notification of registration if the requirements are met.
