Teaser	Your workshop card was stolen? Then you can apply for a replacement card at the responsible office.
Volltext	<p>The workshop card is a tachograph card for</p> <ul style="list-style-type: none"> <li>• approved manufacturers of tachographs,</li> <li>• vehicle manufacturers,</li> <li>• workshops as well as</li> <li>• their responsible specialists such as installers or technicians.</li> </ul> <p>The workshop card is used by your responsible specialists to install, test, calibrate and download data from digital tachographs.</p> <p>If your workshop card has been stolen, you can apply for a replacement card from the responsible office as an entrepreneur or as a person authorized to represent the company or as an authorized representative. To do this, you must present a current certificate of recognition or commissioning of the workshop for testing tachographs. This must not be older than 3 years.</p> <p>Your replacement workshop card remains valid until the same date as the stolen original card - if it would have been valid for more than 6 months. The validity period therefore does not start all over again. If the remaining term of the card is less than 6 months, you</p>

will be issued a new card. This is then valid again for one year.

Whenever you apply for a workshop card to be replaced due to theft, you as the company must provide proof that the instructed specialist is still employed by you and has been trained in accordance with the tachograph card and recording equipment training guidelines. The training certificate must not be older than 3 years.

The workshop card is PIN-protected. The personal PIN number is sent to the employee's home address. Employees may only have one workshop card per employment relationship and may only use it there. The workshop card is the property of the company.

## Erforderliche Unterlagen

- Application for issuance of a workshop replacement card due to theft
  - verifiable documents concerning the name, address and registered office of the workshop, tachograph manufacturer or vehicle manufacturer
  - proof of identity of the entrepreneur or the person or persons authorized to represent the company by law, the articles of association or the partnership agreement
  - Proof of identity and notification of the native language of the specialist for whom the workshop card is being applied for
  - Proof of training of the responsible specialist according to the tachograph tachograph training guideline.
    - not older than 3 years
  - Proof of the employment relationship of the responsible specialist
  - Proof of recognition or commissioning of the workshop (according to § 57b StraßenverkehrsZulassungs-Ordnung)
    - Not older than 3 years
  - Proof of a theft report to the police

Verfahrensablauf	<p>State of Brandenburg:</p> <p>Depending on the driving licence authority, you can apply for a replacement of your workshop card with the necessary documents and information online or on site.</p> <p>Hint:</p> <p>If a serious offence (including both criminal offences and administrative offences) is found during the replacement, the issuance of the workshop card may be refused and the application rejected.</p> <p>If necessary, administrative offence or fine proceedings will then be initiated</p>
Bearbeitungsdauer	<p>5 Werktag(e)</p> <p>State of Brandenburg: Varies between driving licence authorities. If complete application documents are submitted, processing takes up to a maximum of 5 working days.</p>

  - apply for the replacement of a workshop card due to theft
    - Be able to make a request
      - entrepreneurs or
      - persons authorized to represent the company or persons with power of attorney
    - Workshop card is a tachograph card for
      - approved manufacturers of tachographs,
      - vehicle manufacturers,
      - workshops as well as
      - their responsible specialists (installers)
    - Workshop card used by specialists to install, test and calibrate digital tachographs and download their data
      - validity: 1 year
      - required documents among others:
        - Name, address and registered office of the workshop, tachograph manufacturer or vehicle manufacturer.
        - proof of identity of the entrepreneur or of the person or persons authorized to represent him/her by law, the articles of association or the partnership agreement
        - Proof of identity and notification of the native language of the specialist for whom the workshop card is being applied for
        - Proof of training of the specialist in accordance with the tachograph and recording equipment training guidelines.
          - not older than 3 years
        - Written proof that the responsible specialist continues to work in the company or in the workshop.
        - Proof of recognition or commissioning of the workshop (in accordance with § 57b of the Road Traffic Licensing Regulations)
          - Not older than 3 years
        - Proof of a theft report to the police
        - Responsible: different authorities depending on the federal state, e.g. driving license authority, TÜV, Dekra or others
