Teaser	If you need to have your inherited firearms blocked, you must report this to the relevant firearms authority.
Volltext	If you have inherited weapons and/or ammunition that require a permit, do not have a gun ownership card and cannot prove a need to possess the inherited weapons, you must render the inherited weapons unusable or have them fitted with a state-of-the-art blocking system. Ammunition requiring a permit must be rendered unusable or given to an authorized person. The blocking system must be installed by a recognized gun dealer or gunsmith. They will also issue you with proof of installation. The Physikalisch-technische Bundesanstalt (PTB) in Braunschweig tests the conformity and approves newly developed blocking systems in accordance with the Technical Directive - Blocking Systems for Inherited Weapons. Further information, including the current status of the blocking systems available on the market, can be found on the website of the Physikalisch-Technische Bundesanstalt (PTB) under "Further information" If there is no state-of-the-art blocking system on the market for one or more inherited weapons, you can apply for an exemption from the obligation to secure all inherited weapons with a state-of-the-art blocking system.

Kurztext	• Indication of the installation of a blocking system for inherited weapons • Inherited weapons must be fitted with a blocking system if the heir cannot prove a need under firearms legislation • Blocking is not required if the heir has other weapons requiring a license • Blocking systems may only be installed by the holder of a firearms manufacturing license or firearms trading license who also issues corresponding proof. • If no blocking systems are available on the market for the inherited firearms, then proof is also required from the holder of a firearms manufacturing license or firearms trading license • Responsible: Weapons authority
