Teaser	As the operator of a medium-sized combustion plant, gas turbine or internal combustion engine plant, you must determine the pollutant emissions under certain conditions by means of continuous measurements and prepare a measurement report on the results.
Volltext	If you operate a medium-sized combustion plant, gas turbine or internal combustion engine plant, you must determine pollutant emissions by means of continuous measurements under certain conditions. You must prepare a measurement report on the results of the measurements for each calendar year and send this to the immission control authority responsible for you by the deadline.

Voraussetzungen	• You are the operator of a medium-sized combustion, gas turbine or internal combustion engine plant. • You have put your plant into operation.

Verfahrensablauf	• You evaluate the continuous measurements of each calendar year.

Modul	Sachverhalt
	• You prepare a measurement report on the results. • You send the measurement report to the immission control authority responsible for you by the deadline.
Bearbeitungsdauer	There is no statutory processing time.
Frist	• You must submit the measurement report for each calendar year to the responsible immission control authority by March 31 of the following year at the latest. • You must keep the measurement report and the records of the measuring devices for at least 6 years after the end of the respective reporting period.

Kurztext	• Measurement report on continuous measurements of air pollutants Receipt for medium-sized combustion plants • Operators of certain medium-sized combustion plants, gas turbines and combustion engine plants must continuously measure, record and evaluate their pollutant emissions using suitable measuring equipment. As a rule, the measurement must be carried out by an accredited measuring institute or an expert • Reason for measurement: Commissioning of the system or Emission-relevant change to the system • Deadline for measurement: Within 4 months of commissioning or an emission-relevant change • Responsible: competent immission control authority
