Volltext	<p>If you are the operator of a large combustion plant, gas turbine or internal combustion engine plant, you must determine, record and evaluate its pollutant emissions on an ongoing basis by means of continuous measurements.</p> <p>You must regularly prepare a measurement report on the results of the continuous measurements and send it to the responsible immission control authority within certain deadlines.</p>

Verfahrensablauf	<ul style="list-style-type: none"> <li>• You evaluate the continuous measurements of each calendar year.</li> <li>• You prepare a measurement report on the results.</li> <li>• You send the measurement report to the immission control authority responsible for you by the deadline.</li> </ul>
Bearbeitungsdauer	There is no statutory processing time.
Frist	<ul style="list-style-type: none"> <li>• You must submit the measurement report for each calendar year to the responsible immission control authority by March 31 of the following year at the latest.</li> <li>• You must keep the measurement report and the records of the measuring devices for at least 5 years after the end of the respective reporting period.</li> </ul>

- The measurement report must be submitted to the responsible immission control authority by March 31 of the following year at the latest
- The operator must keep the measurement report and records of the measuring devices for 5 years after the end of the respective reporting period
- Responsible: competent immission control authority
