Teaser	If you have a license to operate a betting agency, you must notify the competent authority immediately of any change in the circumstances relevant to the granting of the license.
Volltext	The license for the operation of a betting agency is tied to a specific person and location. The licensing authority must therefore be informed immediately of any changes to the operational circumstances or other changes to the circumstances relevant to the granting of the license in order to be able to amend the license accordingly if necessary. This includes, for example, a change in the legal form of the operator and a change in the person authorized to represent/responsible.
Erforderliche Unterlagen	• Presentation of the facts underlying the amendment
Voraussetzungen	Your operational circumstances or other circumstances relevant to the granting of a license to operate a betting agency have changed.
Kosten	The costs depend on the administrative effort for the specific change applied for and are within the fee range for a license to operate a betting agency. This is between EUR 20.00 and EUR 5,000.00 (tariff no. 2.IV.1/2.1).
Verfahrensablauf	The application to amend the license to operate a betting agency must be submitted by the sports betting organizer or operator to the government in whose district the betting agency is located. The amended permit notice is issued to the betting

Frist	Changes to the legal form must be notified at least one month before they are intended to take effect.
