Teaser	Are you moving into an apartment for which no license fee is paid yet? Then you must register this apartment for the broadcasting fee.
Volltext	<p>The license fee secures the funding of ARD, ZDF and Deutschlandradio. With their programs, the broadcasters inform, educate and entertain many millions of people every day.</p> <p>Thanks to solidarity-based financing, public service broadcasting in Germany can operate independently of political and economic interests. For this reason, citizens must pay a broadcasting fee of EUR 18.36 for every apartment, regardless of how many people live in the apartment:</p> <ul style="list-style-type: none"> <li>• If you move into an apartment, you register the apartment with the ARD, ZDF and Deutschlandradio contribution service for the broadcasting fee.</li> <li>• If you live in the apartment with several adults, you can decide for yourself who registers the apartment.</li> <li>• If you move into an apartment for which a license fee is already paid, you do not need to register for the license fee.</li> </ul> <p>You must register the apartment from the beginning of the month in which you move into it.</p> <p>The amount of the broadcasting fee and its due date are regulated by law. This means that you must pay the broadcasting fee even if you have not received a special request for payment.</p> <p>You can register online.</p> <p>In special cases, you can be exempted from the</p>

	<p>broadcasting fee or apply for a fee reduction.</p> <p>Are you already registered for the broadcasting fee with an apartment? You can also use the online portal to register another home, for example a second home, secondary residence or privately used vacation home.</p>

Kosten	<p>Contribution: 18,36 EUR</p> <p>Payment method: SEPA direct debit or bank transfer Registration of the apartment is free of charge. You must then pay the broadcasting fee for the registered apartment. You can adjust the payment frequency as follows:</p> <ul style="list-style-type: none"> <li>• statutory payment method in the middle of 3 months: EUR 55.08</li> <li>• quarterly in advance on the first of a quarter for 3 months: EUR 55.08</li> <li>• half-yearly in advance on the first of each half-year for 6 months: EUR 110.16</li> <li>• annually in advance on the first of each year for 12 months: EUR 220.32</li> </ul>

- In the next step, enter the details of the apartment to be registered.
- You can also register an apartment at a different address.
- Enter the date of registration in the format month/year.
- Then specify the payment method.
- Select the desired payment frequency from the default settings.
- Specify whether you want to pay by direct debit or bank transfer.
- If you select "Direct debit", additional input fields will open to enter the account details. In this case, you confirm that you authorize the ARD, ZDF and Deutschlandradio contribution service to collect the amount.
- In the last step, you will be shown a summary of your data.
- Check the data you have entered and correct it if necessary.
- To make a correction, click on the "Correct" checkbox in the relevant section.
- After entering all the data, you must confirm that you have read the information on data protection.
- Then enter the randomly generated number, the so-called captcha. You can read this on an image and finally confirm your registration by clicking on the "Log in" selection field.
- You will then be taken to an overview page. All the data you have entered is summarized there. You can print out the data or save it in PDF format.

Alternatively, you can also register by post or telephone.

- Call up the form for registering an apartment on the website "rundfunkbeitrag.de" in PDF format.
- Fill in the PDF form, print it out and sign it. Then send it by post to the ARD, ZDF and Deutschlandradio contribution service.

<b>Bearbeitungsdauer</b>	The Beitragsservice will process your registration immediately.
<b>Frist</b>	You must register immediately after moving into the apartment.
