Teaser	You are a driver of a truck or bus and your driver card was stolen? Then you need to apply for a replacement card.
Volltext	The driver card is used to record driving and rest times in the commercial transport of goods and passengers. If you are a driver of trucks or buses and your driver card has been stolen, you can apply for a replacement card from the office responsible for you. The replacement driver card is valid until the same date as the stolen original card - if it would have been valid for more than 6 months. Therefore, the validity period does not start all over again. From the time you lose your driver card, you may continue to drive without a valid driver card for a maximum of 15 days. As long as you are not in possession of your driver card, you must record the driving and rest times manually. You must make printouts of these from the digital tachograph and carry them with you. Your employer is not obliged to reimburse you for the cost of the driver card.
