Volltext	In order to practice medicine without a medical license or license to practice medicine, a permit is required in accordance with the Heilpraktikergesetz. Various requirements must be met for this. The Heilpraktiker license may not be restricted to individual areas. There is an exception for the field of psychotherapy and for the healthcare professions of physiotherapy, speech therapy, occupational therapy and podiatry.
