Teaser	Motor sport events - both on the road and in other areas - require a permit.
Volltext	A motor sport event that is not to take place exclusively on public traffic areas requires a permit under safety law from the district authorities, independent cities or large district towns.
Erforderliche Unterlagen	In addition to the name of the organizer, the application must also contain information about the type, location and time of the event as well as the number of participants to be admitted. • Permit application
Voraussetzungen	An organizer in this sense is anyone who creates the conditions for the holding and implementation of the event through organization and management or in any other significant way. In addition to naming the organizer, the application must in any case contain information on the type, place and time of the event as well as the number of participants to be admitted.
Kosten	The fee range for issuing the permit is EUR 30.00 to EUR 1,250.00 (tariff no. 2.II.1/3 of the schedule of costs). Any disbursements must be added to this.

Frist	However, it is advisable to submit the application for a permit at an early stage. The complete application for a permit must be submitted to the competent authority in good time so that it has a reasonable period of time to review the eligibility for approval."
