Special responsibility of property owners and builders

- Property owners are generally responsible for eliminating specific dangers posed by explosive ordnance on their property.
- The responsibility for hazards posed by explosive ordnance during construction work lies with the building owners. They must also investigate any suspicion of explosive ordnance, initiate the necessary measures and commission the appropriate specialist companies to do so.
- The basis for precautionary measures is primarily property-related historical research and a related risk assessment. In most cases, the municipalities also have archival documents on war-related events.
- It is the responsibility of the relevant specialist companies to produce and certify the so-called "freedom from explosive ordnance". The assessment of the explosive ordnance contamination of properties is also not part of the tasks of the Explosive Ordnance Disposal Service or other departments.
- Explosive ordnance found or recovered by specialist companies will be disposed of free of charge by the Explosive Ordnance Disposal Service.

Notes, information and rules of conduct

Relevant instructions, information and rules of conduct on the dangers posed by explosive ordnance and how to avert them can be found in the notice "Averting dangers posed by explosive ordnance". The notice can be accessed via the website of the State Ministry of the Interior, for Sport and Integration (see "Related links"), together with information on how to proceed in the case of properties that may be contaminated with explosive ordnance and the address lists "Specialist companies for the disposal of explosive ordnance" and "Specialist companies for the evaluation of aerial photographs".
